## MODIFICATION OF RIGHTS

- 8 1) If at any time share capital is divided into different ClaliSeS of shares, the rights attached to any class (unless otherwise provided by the terms of issue of the shares of that class) may, subject to the provisions of section 105 and 107 and whether or not the company is being wound up be varied with the consent in writing or the holders of three fourths of issued shares of the class, or with the sanction of a special resolution passed at a separate meeting of the holders of the shares of that class.

- 28. - 65. Any business other than that upon which a poll has been demanded may be proceeded with pending the taking of the poll.

## VOTES OF MEMBERS

- 66. Subjects to the rights or restrictions for the time being attached to any class or classes of shares.
  - (a) on a show of hands, every member present in person shall have, on vote; and.
  - (b) on a pol, the voting rights of members shall be at laid down in section 87.
- 67. In the case of joint holders the vote of the senior who tenders a vote, whether in person or by proxy shall be accepted in the exclusion of the votes of the other joint holders.

For this purpose, seniority shall be determined by the order in which the names stand in the register of members.

- 68. A member of unsound mind, or in respect of whom an order has been made by any Court having jurisdiction in lunacy, may vote whether on a show of hards or on poll, by his committee or other legat guardian, and any such committee or quardian may vote by proxy on a poll.
- 69. No, member shall be entitled to vote at any general meeting unless all calls or other sums presently payable by him in respect of shares in the company have been paid.
- 70. (1) No objection shall be raised to the qualification of any voter except at the meeting of adjourned meeting at which the vote objected to is given or tendered, and every vote not disallowed at such meeting shall be valid for purpose.
  - (2) Any auch objection made in due time shall be referred to the chairman of the meeting, whose decision shall be final and conclusive.
- The instrument appointing a proxy and the power of attorney or other authority, if any, under which it is signed or a notarially certified copy of that power or authority, shall be deposited at the register office of the company not less than 48 hours before the time for holding the meeting or adjourned meeting at which the person named in the instrument porposes to vote or, in the case of a poll, not less than 24 hours before the time appointed for the taking of the poll; and in default the instrument of proxy shall not be treated as valid.
- 72. An instrument appointing a proxy shall be in either of the forms in Schedule IX to the Act or a form as near thereto as circumstances admit.
- 73. A vote given in accordance with the terms of an instrument of proxy shall be valid, notwithstanding the previous death or insanity of the principal or the revocation of the proxy or of the authority under which the proxy was executed, or the transfer of the shares in respect of which the proxy is given.

Provided that no intimation in writing of such death, insanity, revocation of trans. at shall have been received by the company at its office before the commencement of the meeting or adjourned meeting at which the proxy is used.

## DIRECTORS

- 74. On the date of adoption of these Articles the Directors of the Company are
  - 1. SR! ARVIND KAJARIA
  - 2. SRI SUNIL KAJARIA
  - 3. SRIP S. CHAKRABART11
- Unless otherwise determined by The Company in a General meeting, the number of Directors shall not be less than three and more than twelve.
- 76, the Directors of the Company are not required to hold any share in the Company as qualification shares.
- 77. (1) Each Director shall be entitled to received out of the funds of the Company for attending meeting of the Board of a Committee thereof such sum as fees as shall be determined from time to time by the Directors but not exceeding such sum as may be prescribed from time to time for every such meeting attended by him. In addition, subject to the provisions, of section 309 all the Directors may receive a commission up to three percent (3%) on the net profit of the Company as computed under the provisions of the Companies Act, 1966, and such commission shall be divided amongst thom equally or as the Directors may determine. The Directors may waive or reduce their fee for any meeting or period.
- (2) Any Director performing extra service of making any special exertion for any of the purposes of the company or who is a managing or whole time director, may be paid such fixed sum or remuneration either by way of monthly payment or at a percentage of profit or in any other manner as the Company may determine, subject to the provisions of the Act.
- (3) The remuneration of the Directors shall, in so far as it consists of a monthly payment, be deemed to acquire from day to day.
- (4) In addition to the remuneration payable to them in pursuance of the Articles to Directors may be paid all travelling hotel and other expenses properly incurred by them.
- in attending and returing from meetings of the Board of Directors or any committee thereof or general meetings of the Company.
  - In in connection with the biseness of the Company
- The company may exercise the powers conferred on it by section 157 and 158 with regard to the keeping of a register, and the Board may (subject to the provisions of those section) make and very such regulations as a many think for respecting the provision of their such register.

- All cheques, promissory notes, drafts, hundles, bills of exchange and other negotiable instruments and all receipts for moneys paid to the company, shall be signed, drawn, accepted endorsed, or otherwise executed, as the case may be, by the managing Director or by such person and in such manner as the Company in General Meeting or the Board shall from time to time by resolution determine.
- 81. Every director present at any meeting of the Board or of a committee thereof shall sign his name in a book to be kept for the purpose.
- 82 (1) The Board shall have power at anytime, and from time to time, to appoinment a person as an additional director, provided the number of the directors and additional director together shall not at any time exceed the maximum strength fixed for the Board by the articles.
  - (2) Such person shall hold office only up to the date of the next annual general meeting of the Company but shall be eligible for appointment by the company as a director at that meeting subject to the provisions of the Act.
- 83. (1) The Board of Directors shall also have power to Fill up a casual vacancy in the Board. Any Director so appointed shall hold office only so long as the vacating Director would, have held the same if no vancancy had occured.
  - (2) The Board may appoint any person to act as an alternate director for a Director during the later's absence for a period of not less than three month from the state in which meetings of the Board are ordinarily held and such appointment shall have effect and such appointee, whilest he holds office as an alternate director, shall be entitled to notice of meeting and to attend and vote there at accordingly; but he shall "lose facto" vacte office, if and when the absent Director returns to the state in which meetings of the Board are ordinarily held or the absent Director vacates office as a Director.
- 8.4. If it is provided by any agreement, deed or other documents securing or otherwise in connection with any loan taken by the Company or in connection with taking of any shares by any person, that any such person or persons shall have power to nominate a Director on the Board of Directors of the Company then and in case of taking of any such loan or shares or entering into such agreement the person or persons having such power may excercise his power from time to time appoint a Director accordingly. Such Director may be removed from Office at any time by the person or persons in whom the power, under which he was appointed is blested and another Director may be appointed in his place but while helding such office he shall not be liable to retire by rotation nor hold any qualification shares.

#### PROCOEDINGS OF BOARD

- The Board of directors may meet for the purpose of business, adjourn and otherwise regulate its meetings, as it thinks fit, subject to the provisions of section 286 of the Act.
  - (2) A director may, and manager or secretary on the requisition of a director shall at any time, summon a meeting of the Board.
- 86. (1) Save otherwise expressly provided in the Act, questions arising at any meeting of the Board shall be decided by majority of votes.
  - (2) In case of an equality of votes, the chairman of the meeting shall have a second or casting vote.
- 87. The continuing directors may act notwithstanding any vacancy in the Board, but if and so long as their number is reduced below the quorum fixed by the Act for a meeting of the Board, the continuing directors or director may act for the purpose of increasing the number of directors to that fixed for the quorum, or of summoning a general meeting of the company, but for no other purpose.
- The Board may elect a chairman of its meeting and determine the period for which he is to hold office.
  - (2) If no such chairman is elected, or if at any meeting the chairman is not present within five minutes after the time appointed for holding the meeting the directors present may choose one of their member to be the chairman of the meeting.
- 89. (1) The Board may, subject to the provisions of the Act, delegate any of its powers to a committee consisting of such member or members of its body as it think fit.
  - (2) Any committee so formed shall, in the exercise of the powers so delegated confrom to any regulations that may be imposed on it by the Board.
- 90. (1) A committee may elect a chairman of its meetings.
  - (2) If no such chairman is elected, or if at any meeting the chairman is not research within five minutes.
- A committee may meet and adjourn as it thinks proper.

- (2) Question arising at any meeting of a committee shall be determined by a majority of votes of the members present, and in case of an equality of votes, the chairman shall have a second or casting vote.
- 92. All acts done any meeting of the Board or of a committee thereof or by any person acting as a director, shall, notwithstending that it may be afterwards discovered there was some defect in the appointment of any one or more of such directors of any person acting as aforesaid, or that they or any of them were disqualified, be a valid as if every such director of such person had been duty appointed and was qualified to be director.
- 93. Save a otherwise expressly provided in the Act, a resolution in writing signed by the members of the Board or of a committee there of in accordance with the provisions of section 289, shall be as valid and effectual as if it had been passed at a meeting of the Board or committee, duly convened and held.

## POWERS OF DIRECTORS

Subject to the provisions of the Act the control of the Company shall be vested in the Board who shall be entitled to exercise all such powers, and to do all such acts and things as the Company is authorised to exercise and do: provided that the Board shall not exercise any power or do any act or thing which it directed or required, whether by the Act or any other Statute or by the Memorandum of the Company or by these Articles or otherwise, to be exercised or done by the Company in General Meeting.

Provided further that in exercising any such power or doing any such act or thing, the Board shall be subject to the provision in that behalf contained in the Act or any other statutes or in the Memorandum of the Company or in these Articles or in any regulation not inconsistent there with and duly made there under, including regulations made by the Company in General Meeting and no such regulation shall invalidate any prior act of the Board which would have been valid if that regulation had not been made.

95. Subject to and in accordance with the provisions of the Act, the Board shall retain and employ such staff as may be necessary for carrying on the business of the Company. The salary or other remuneration of such staff shall be defrayed by the Company and all or any of such staff be engaged exclusively for the Company or jointly with other concerns.

#### **BORROWING POWERS**

- 96. (1) The Board may from time to time at its discretion, subject to the provision of the Act, raise or borrow, either from the Directors or from elsewhere and secure the payment of any sum or sums of money for the purpose of the Company.
  - (2) The Board may raise or set are the repayment of such sum or sum in such manner and upon such terms and conditions in all respects as it thinks fit and in particular by the issue of bonds prepetual or redeemable detentures or detenture stock, or any mortgage, charge or other security on the undertaking or the whole or any part of the property of the Company (both present and future), including its uncalled capital for the time being.
- 97. If uncalled, capital of the Company is included in or charged by mortgage or other security, the Board may be instrument under the Company's seal authorise the person in whose favour such mortgage or security is executed or any other person in trust for him to collect money in respect of calls made by the Board on members in respect of such uncalled capital and the provisions hereinbefore contained in regard to call shall mutatis mutandish apply to calls made under such authority; and such authority may made exercisable either conditionally or unconditionally, ether presently or contingently and either to the exclusion of the Directors power or otherwise and shall be assignable if expressed so to be.
- 98. Debentures, bonds and other securities may made assignable, free form any equities, between the company and the person to whom the same may be issue.
- 99. Subject to the provisions of Act any debenture, bonds or other securities may be issued by the Company at a discount, premium or otherwise, with any special privileges as to redemption, surrender, drawings allotment of shares, appointment of Directors or otherwise Debentures and bonds with right to allotment of or conversion into shares shall not be luuued except with the sanction of the Company in general meeting and compliance of the provisions of the Act.

## MANAGING DIRECTOR, MANAGER OR SECRETARY ETC.

- 100. Subject to the provisions of the Companies Act, 1956 the Company in general meeting or the Directors may at any time appoint one or more Directors as Managing Director or whole time director on such remuneration, terms and conditions as may be decided by them or such meeting. A whole time or Managing Director shall not be liable to retire by rotation.
- 101. Subject to the provision of the Act a manager or secretary may be appointed by the Board for such term, at such conditions as it may think fit, and any manager or secretary so absolnted.
- Subject to the provision of section 269 and 314 of the Act a Director may be appointed as manager or secretary.

103. A provision of the Act or these Articles requiring or authorising a thing to be done by a director and the manager or secretary shall not be satisfied by its being done by the same acting both as director and as, or in place of theF manager or secretary.

#### THE SEAL

- 104. (1) The Board shall provide for the safe custody of the seal.
  - (2) The seal of the company shall not be affixed to any instrument except by the authority of a resolution of the Board or of a committee of the Board authorised by it in that behalf, and except in the presence of at least one director or secretary or such other person as the Board may appoint for the purpose; and the director or secretary or other person aforesaid shall sign on every instrument to which the seal of the company is so affixed in his presence, subject to the provisions of Article 10 hereof, in respect of share certificates.
  - (3) The company may exercise the powers shall conferred by section 50 regard to having an official seal for use aborad and such powers shall be vested in the Board.

## DIVIDENDS AND RESERVES

- 105. The company in annual general meeting may declare dividends, but no dividend shall exceed the amount recommended by the Board.
- 106. The Board may from time to time pay to the members such interim dividends as appear to it to be justified by the profits of the company.
- 107. (1) Subject to the provision of the act. The Board may before recommending any dividend, set aside out of the profit of the company such sums as it thinks proper as reserve or reserves which shall at the discretion of the Board, be applicable for any purpose to which the profits of the Company may be properly applied, including provision for meeting contingencies or for equalising dividends, and pending such application, may, at all like discreation either be employed in the business of the company or be invested in such investment (other than shares in the company) as the Board may from time to time think fit.
  - (2) The Board may also carry forward any profits which it may think prudent not to divide, without setting them aside as reserve.
- (1) Subject to the right of person, if any, entitled to shares with special rights as to dividends all dividends, shall be declared and paid according to the amounts paid or credited as paid on the shares in respect of which the dividend is paid, but if and so long as nothing is paid upon any of the shares in the company dividends may be declared and paid according to the nominal amounts of the shares.
  - (2) No amount paid or credited as paid on a shares in advance of calls shall be treated for the purposes of the Article as paid on the share.
  - (3) Unless otherwise decided by the Board all dividends shall be apportioned and paid proportionately to the amounts paid or credited as paid on the shares or any portion or portions of the period in respect all rank for dividend of which the dividend is paid, but if any share is issued on terms providing that shall as from a particular date such share shall rank for dividend accordingly.
- 109. The Board may deduct from any dividend payable to any member all sums of money if any presently payable by him to the company on account of calls or otherwise in relation to the shares in the company.
- 110. No unclaimed or unpaid dividend shall be forfeited by the Board. All dividends remaining shall be dealt with in the manner as provided under Section 205A of the Companies Act. 1956.
- 111. (1) Any dividend, interest or other moneys payable in cash in respect of share may be paid by chaque or warrant sent through the post directed to the registered address of the holder or in the case of joint holders, to the registered address of that one of the joint holders who is first named on the register of members or to such person and to such address as to the holder or joint holders may in writing direct.
  - (2) Every such cheque or warrant shall be made payable to the order of the person to whom it is sent.
- 112. Any one of two or more joint holders of a share may give effectual receipts for any dividends, bonuses of other moneys payable in respect of such share.
- 113. Notice of any dividend that may have declared shall be given to the persons entitled to share therein in the manner mentioned in the Act.
- 114. No dividend shall bear interest against the Company accept as provided under law. ACCOUNTS

proces and under what conditions or regulations, the accounts and books of the Company, or any of them, shall be open to the inspection of members not being directors.

- 116. (1) The Company in general meeting may, upon the recommendation of the Board resolve

  - (b) that sum be accordingly set free for distribution in the manner specified in the clause (2) amongst the members who would have been entitled thereto. If distributed by way of dividend and in the same proportions.
  - (2) The sum aforesaid shall not be paid in cash but shall be applied, subject to the provision confined in clause (3) either in or towards.
  - (ii Paying up any amount for the time being unpaid on any share held by such members respectively
  - Paying up in full, unissued shares of the company to be allotted and distributed, credited as fully paid up, to and amongst such members in the proportions aloresaid.
  - (iii) party in the way specified in sub clause (i) and party in that specified in Subclause (ii)
  - (3) A share premium account and a capital redemption reserve fund may, for the purposes of these Articles be applied only in the paying up of unissued shares to the members of the company as fully paid bonus shares.
  - (4) The Board shall give effect to the resolution passed by the company in pursuance of these Article.
  - 117. (1) Whenever such a resolution as aforesaid shall have been passed the Board shall
    - (a) make all appropriations and applications of the undivided profits resolved to be capitalised thereby, and all allictments and issues of fully poid shares, and
    - (b) generally do all acts and things required to give effect thereto.
    - (2) The Board shall have full power
    - to make such provision, by the issue of fractional certificates or by payment in cash or otherwise as it thinks fit, if the case of shares becoming distributable in facuous: and also
    - (b) to authorize any person to enter, on behalf of all the members entitled thereto into an agreement with the Company providing for the allotrient to them rispectively credited as fully paid up, of any further shares to which they may be entitled upon such capitalization, or (as the case may require) for the payment by the company on their behalf, by any application thereto of their respective proportions of the profits resolved to be capitalise, of the amounts or any part of the amounts remaining unpaid on their existing shares.
    - (3) Any agreement made under such authority shall be effective and binding on all such members.

## WINDING UP

- 118. (1) If the company shall be wound up, the liquidator may, with the sanction of a special resolution of the company and any other sanction required by the Act, divide amongst the members, in special or kind, the whole or any part of the assets of the company whether they shall consist of property of the same kind or not.
  - (2) For the purpose aforesaid, the liquidator may set such value as he deems fair upon any property to be dividend as aforesaid and may determine how such division shall be carried out as between the members or different classes of members.
  - (3) The liquidator may, with the like canction, west the whole or any part of such assests in trustees upon such trust for the benefit of the contributories as the liquidator, with the like canction, shall think fit, but so that no member shall be compelled to accept any shares or other securities where on there is any liability.

## MEMBERS

119. Every person who is a subscriber to the Memorandum and Articles and/or who intends to be or becomes a member of the Company shall, subject to the provision of any law in force, be bound by the provision of the
